

1. What personal information do we collect from the people who visit our blog, website or app?

When registering on our site or participating in an online event conducted on the main website or a subsite of Pragyan, as appropriate, you may be asked to enter your name, email id, mailing address, phone number or other details to improve your experience.

2. When do we collect information?

We collect information from you when you register, login, sign up for an online event, respond to a survey or marketing communication, surf the website, or use certain other features on our site.

3. How do we use your information?

We may use the information we collect from you in the following ways:

- Intimate information pertaining to events which may include schedules, pattern, modifications and change of dates (if any).
- Providing relevant event participation certificates and prize money.

4. How do we protect visitor information?

Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our site as safe as possible. We use regular Malware Scanning and also an SSL Certificate.

We only provide articles and information and never ask for personal or private information like credit card numbers, bank log in details or any other authorization for transactions.

5. Do we use 'cookies'?

Yes. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser to capture and remember certain information. For instance, we use cookies to help us remember and help you continue from a particular stage/level in labyrinth (An online treasure hunt). They are also used to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data about site traffic and interaction so that we can offer better site experiences and tools in the future.

6. Third Party Disclosure

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information unless we provide you with advance notice. This does not include trusted third parties who assist us in operating our website, conducting our festival, or servicing you, so

long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or other's rights, safety or property.

However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other purposes.

7. Third party links

Occasionally, at our discretion, we may include or offer third party products or services on our website. These third party sites have separate and independent privacy policies. We therefore have no responsibility or liability for the content and activities of these linked sites. Nonetheless, we seek to protect the integrity of our site and welcome any feedback about these sites.

8. How does our site handle Do Not Track signals?

We honour Do Not Track signals and we do not track, plant cookies, or use advertising when a Do Not Track (DNT) browser mechanism is in place.

9. Does our site allow third party behavioural tracking?

No, we do not allow third party behavioural tracking.

10. Fair Information Practices

In order to be in line with Fair Information Practices, we will take the following responsive actions, should a data breach occur:

- We will notify the users via email within 7 business days
- We will notify the users via in-site notification within 1 business day

11. Email usage

- Confirm your participation in our events.
